In 2021, the GAT has prioritized three areas of focus - Building trust through collaboration and engagement, workforce planning focused on current and emerging gaps in tailings expertise and enhancing access to tailings content across GMPA member associations.

In addition, GMPA members are providing tailings content, conferences, professional certification, handbooks and technical papers to contribute to a knowledge base of good tailings practice.

SME is leading the preparation of a handbook to be published in 2022, 'The Tailings Management Handbook: A Lifecycle Approach', which will include content from more than 50 contributors on: Background on Tailings Management; Planning; Design & Construction; Operations; Closure; and Innovation as well as feature 25 case studies.
